 - iv. Steve spoke in lieu of Bruce;
 - \$15,320 was erroneously transferred, without our approval, from checking to reserves in December duplicating a transfer we had already made in October. This error was noted to HOACS and the transfer is supposed to be reversed.

 - Violations have been issued and the violation will resume, as the issue has not been consistently resolved.
 - b. Basketball Hoop 83
 - i. Violations have been issued
 - c. White picket fence in front of property 66
 - i. Tom suggests research on utilities buffer zone
 - ii. Discussion ensued and due to the fact that the owners of the property have not responded to any inquiries or violations, it was decided that it is time to pursue fines.
 - d. ACC will get a list of outstanding violation letters from Jill
- 5. Old Business
 - 1. Snow removal information Marc & Tom
 - 1) Snow removal companies did not respond to our phone calls or requests for quotes.
 - i. Marc is talking to Gig Harbor Tree Company. Joe McGhee has promised a quote to Marc.
 - ii. Larger companies who are more reliable would ask us to sign a contract. Their service involves putting down pretreatment right off the bat but it's about \$3 -4 K per year and that does not even cover plowing. They suggested a smaller company for a neighborhood like ours.
 - iii. Andrew Gordon Trans Blue. Tom talked to them they would put down de-icer at first ice, and come back to plow when it snows, but they prioritize their large contracts first, parking lots, etc...
 - Marc suggests people with big trucks take turns driving around the neighborhood to create tracks of packed powder.
 - 2) What criteria do we want to use to plow or not to plow?
 - i. It was decided we, as a board, will be responsible for making the determination as to whether or not to plow the roads when each weather event occurs, but cannot guarantee the availability of a snow plowing service due to the constraints detailed above with the absence of a costly contract.
