Speed In The Neighborhood: We are asking your help in urging your neighbors and guests to keep that speed limit in check when transiting in or out of the neighborhood. We have had a number of incidents where excessive speed has nearly caused an accident and with LOTS of young kids around, nobody wants anyone to get hurt. There have been calls for speed bumps to be installed and we'd rather that we self-police ourselves rather than resort to that expensive option. Please remember that our speed limit is 20.

HOA Community Solutions/Dues: The January transition to our HOA management firm went off without a hitch, as expected. We are very pleased that most of you had little to no trouble to whom you should pay your dues. PLEASE PLEASE PLEASE read your invoices carefully. A number of our residents are carrying late and/or other fees that are accumulating. If you see extra fees on your invoice, they are due to a number of different reasons, chiefly among them, non payment or late payment. The Board has elected to no longer notify our residents of non payment and fees that accumulate in the interim; it is incumbent on each of us to be responsible for our monies to the Association.

Architectural Control Committee (ACC): ACC Liason, AJ Montgomery, with assistance from Marc Janes, has been busy in the first half of this year. Per our discussion at last fall's annual meeting, this summer will bring increased attention to weeds, watering, and yard upkeep. The overwhelming majority of our residents want our neighborhood to be well maintained and tastefully landscaped. If there is ever any questions as to what is appropriate and expected as a resident here, please reference the bylaws. More than likely, most issues are covered. If it isn't, feel free to approach one of us for closer interpretation. Our job isn't to be a reflexive "No", but we do need to all live within the standards that govern all of us.
